NASH FM 93.7'S "WIN LAHEY FAMILY FUN PARK GIFT CARDS" CONTEST OFFICIAL RULES

The Station will conduct the **NASH 93.7's "Win Lahey Family Fun Park Gift Cards"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 3. **How to Enter.** There is one way to enter.

Facebook: Entrants must:

- (a) Visit the Station's Facebook page at www.facebook.com/nashfm937 during the Contest Period;
- (b) Comment on the "Win Lahey Family Fun Park Gift Cards" Contest post; and
- (c) Include in the comment: #contest.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. - 4. Winner Selection. On or about 11:00am EST on Monday, April 29, 2024, Station will select FIVE (5) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
